SUPPLEMENTARY REGULATIONS v2.0 (update)

Round 1 & 2 RallyX South Valkenswaard (NL) 25-26 April 2026

REGULATIONS

In case of translations, the final text of these Supplementary Regulations shall be the English version which will be used should any dispute arise as to their interpretation. Headings in this document are for ease of reference only and do not form part of these Supplementary Regulations.

Article 1 – Organisation

The Competition shall be run in accordance with the 2026 RallyX general, sporting and technical regulations, 2026 KNAF Regulations Book, specified articles of 2026 KNAF Rallycross Regulations, the FIA International Sporting Code and its appendices and these Supplementary regulations.

Responsibility

Anyone who participates in the race do so under their own responsibility and at their own risk. FIA, KNAF, NRV/Eurocircuit, RX Promotion AB and officials cannot be liable for personal injury or property damage during the competition.

Noise check + Scrutineering:

The noise check and scrutineering will take place between 09:30-14:00 via the process below (see IMAGE 1). **Cars first go to the noise check and secondly to the scrutineering bay.**

Please have all documents and drivers' gear ready.

Noise check is mandatory (see rules below).

Sound

With respect to sound produced by the vehicle, the following rules – based on local legislation – apply:

- Maximum number of dBA to be produced is 85, measured with the sound meter placed at position "A" and "Slow" and the microphone placed at 10 m. distance in line with the exhaust pipe, with the engine running at 4,000 rpm (static measurement as part of scrutineering).

- If any part or the entire exhaust system breaks off during the race, it must be reassembled before the next start.
- For the purpose of sound measurement, each car must be equipped with a properly working RPM meter.
- Continuous loud exhaust explosions during the event are prohibited. If this provision is violated, the Clerk of the Course has the option of serving the black flag.
- The drive-by sound level is measured at a fixed location (mounting point for sound meter at guard rail at the foot of the Race Control tower). Maximum noise level for the drive-by measurement shall not exceed 96 dBA.
 - If the 96 dBA limit is exceeded, a warning will follow.
 - If the 98 dBA limit is exceeded, the Clerk of the Course has the option of serving the black flag.

Briefing with the Competitors and Drivers:

Parc fermé

Parc fermé after the finals will be in the area marked in IMAGE 2 (below the race control tower). After finishing, cars will safely (max. 40 kph) drive around the track and exit at Marshall Post 6 to enter Parc Fermé, unless they receive instructions to exit the track at Marshall Post 3..

RallyX Display on Market Square Valkenswaard

To promote the event, there will be a RallyX Display on the Market Square of Valkenswaard. This will be on Friday 24 / 04 / 2026. Drivers and cars selected by the organizer are obliged to participate. They will be **ready to go at 14.30** at the front gate of the track. All vehicles will drive in convoy, led by a vehicle of the organization. Vehicles will remain closely together, there shall be no gaps in the convoy. Burn-outs, donuts, rapid acceleration/ deceleration, high engine revs et cetera are strictly forbidden. Drivers shall obey normal road safety rules. Violation of any of these rules will result in a fine, to be paid to the ASN, of € 1,500.00 per violation. At **19:00** the convoy will return to the Eurocircuit.

Article 4 – Insurances

Article 6.2 and Annex 1 (Waiver of liability) of the 2026 KNAF Rallycross Regulations are applicable.

The Organizer of this competition has an insurance with the KNAF to cover certain liabilities under policy no. [TBC in bulletin] with the following insured amounts: € 7,500,000.00 as a maximum per claim for liability in the event of damage and/or injury, € 7,500,000.00 as a maximum per claim in the event of damage to the environment. € 15,000,000.00 as a maximum per year. Organizer will have a certificate of insurance issued specifically for his event by the KNAF.

Participants are expected to dispose of a health

insurance that does not exclude the risks of participating in this event.

KNAF license holders are insured for Personal Accidents by their license with the KNAF for the following amounts:

At death: € 25,000.00

In case of disability: € 100,000.00 maximum

License holders of other ASN's are expected to be insured for Personal Accidents with their own ASN.

Article 5 – Protests and Appeals

The protest fee is EUR 250 (plus deposit in case of technical protests).

The appeal fee set by the ASN is EUR 1,000.

All protests will be lodged in accordance with the FIA International Sporting Code and the 2026 KNAF Regulations Book. All protests must be made in writing and handed to the Chairman of the Stewards, or in his absence one of the other Stewards of the Competition, or in their absence to the Race Director or Clerk of the Course (or their assistant) together with the required protest fee.

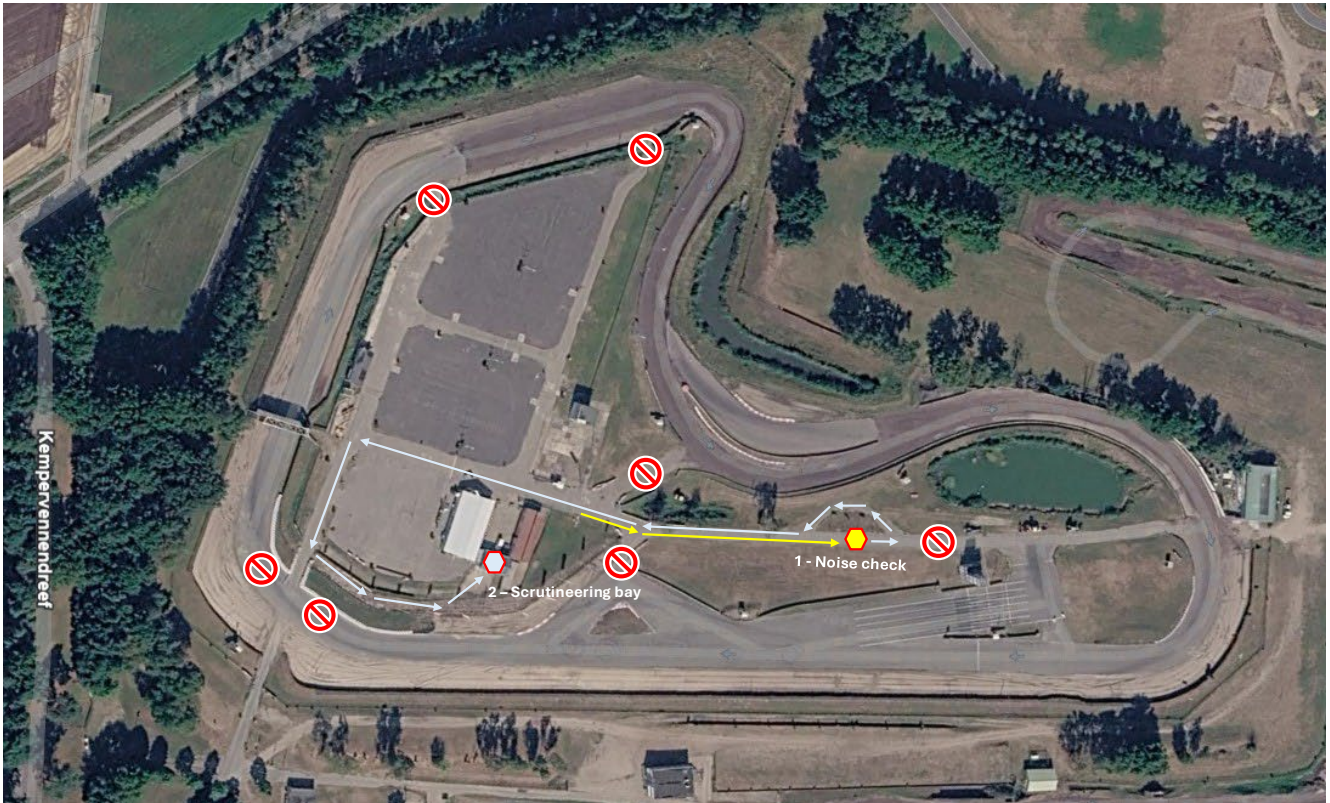


IMAGE 2 - parc fermé
